<u>Public Works Loan - To support Memorial Hall Renovation Project</u>

During 2015/2016 the Parish Council took out a public works loan in the sum of £80,000 to support the Wilbrahams' Memorial Hall Trustees with their renovation project. If the loan were to go full term the total payable by the final date would be £118,238.

VILLAGE NEWSLETTER

Under spending power LGA 1972 s145, the Parish Council part funds the production of joint parish newsletter with Little Wilbraham. Adverts total £811 from 1st April 2020 to 31st March 2021, one third of this, £579, was paid to Little Wilbraham. Cost of production was £1130.52 (3 editions).

Parish Cemetery

Under spending power LGA 1972 s214, the Parish Council is currently undergoing expenditure on developing and maintaining a burial ground. A total of £381.92(ex VAT) was spent over 2020/21.

Maintenance of assets

Spending powers LGA 1974, S142, was used to maintain the noticeboard. PCA 1957, s3 was used to provide street lighting, LGA 1953 s4 was used to maintain the bus shelter, Open Spaces Act 1906 ss9 and 10 was used to maintain the parish cemetery and Highways Act 1980, ss43,50 was used to maintain the bollards on footway.

Open spaces

The Parish Council received £556.25 from CCC towards grass cutting services. Under the Open Act 1906,ss9 and 10, the Parish Council funded the remaining grass cutting costs, donated money towards the upkeep of the recreation and church-burial grounds and performed tree works.
