1 Village Life

Queen's Platinum Jubilee. We provided financial support for celebration in Memorial Hall and presented all village children with a commemorative coin.

Death of HM Queen Elizabeth. We coordinated village events and held a Proclamation for the new King on 10th September 2022.

Ukrainian families. We supported a village group (Wilbrahams Refugee Support) giving help to residents hosting Ukrainian refugees and supporting a family living in the village by providing a grant and allowing the group to run their finances through the Parish Council Unity Bank Account whilst their own account was being set up.

Liaison with village groups including Well-brahams, WEG and Memorial Hall.

Grants. We have provided grants to village initiatives including the Memorial Hall children's Christmas party; Jubilee celebrations, lighting of the star near the village green; Transport Working Group, distribution of 20mph leaflets.

Support for Warbler magazine.

Support for the Memorial Hall – including financially through payment of the Public Works Loan that paid for the new building.

We plan to pursue projects that engage the youth and teens in our village on community matters.

2 Trees and Biodiversity

Tree Warden. We have appointed Nigel Start as our new Tree Warden.

Community Orchard. We have worked with the Well-brahams to prune the fruit trees and have undertaken routine maintenance of the hedges and ditches,

Management of trees and hedges on footpaths and verges, including carrying out inspections of footpaths and roads and working with Highways for major tree works.

We have developed closer working relationships with the Wilbrahams Environment Group (WEG).

3 Highways, Transport and Cycleways

Local Highways Improvement (LHI). We developed a successful application to the County Council, achieving £15,000 support for new traffic calming measures (40mph buffer zones and gates) at the village entrances. These are expected to be installed in Spring 2023.

Speed monitoring devices. We have supported the Transport Working Group in their successful application for a grant for 3 new 'mobile vehicle-activated signs' (MVAS) units. These have now been delivered, volunteers have been trained and the units will be sited in Spring 2023.

Cycling. We are working with Little Wilbraham, WEG and County Councillor Claire Daunton to investigate the possibility of having a bicycle path from our communities to Cambridge.

Carpenters Arms parking. We have worked with the Carpenters Arms to address the problems of parking on the road directly outside the pub.

20mph speed limit. We are developing an application for the introduction of a 20mph speed limit in the village.

4 Planning

Planning applications. We have looked at and commented on 22 planning applications including major proposals related to the use of the chalk quarry site at the top of Mill Road, a possible solar farm at Nine Mile Hill, applications related to listed buildings, and tree works within the village conservation area.

5 Communications

Farmers Markets. We have attended three Farmers Markets which have given us an opportunity to meet and listen to residents and provide information about the Council's work. We plan to attend regularly throughout 2023.

Warbler reports. We have reported to all four editions of the Warbler, providing clear information about our major achievements and our areas of work, and listing upcoming events.

Website and notice boards. Our agendas are always displayed on the Wilbrahams website and on the village noticeboard at least 3 working days before our meetings. We have ensured that key information such as road closures and emergency events are posted on the Wilbrahams website.

Know your Parish Councillors. We have created a page with Parish Councillor photographs and profiles, so that village residents can get to know us better.

WhatsApp communities. We are trialling *WhatsApp Communities* which would enable instant updates and notification from the Parish Council to village residents.

Mobile phone signal. We have provided advice on the website for residents who want to find out about a better mobile phone signal.

Improvements to IT structure. We have begun to investigate improvements in our IT systems to give us better functioning emails and improved document storage.

Business listings. Residents of Great Wilbraham, Little Wilbraham and Six Mile Bottom will soon have the option to list their business for free on the

Wilbrahams website. This is to allow us to develop a local marketplace and make residents aware of what local businesses and services are available.

6 Wider involvement

Commenting on GCP We have commented in detail on the GCP 'Making Connections' consultations and attended seminars and meetings to discuss, develop and share views.

We have engaged with A to B1102, including meetings in Burwell on proposed improvements along the B1102, making representations about travel requirements for the Wilbrahams and traffic problems through the village.

Eastern Access. We have attended meetings and submitted responses about the proposal for the improved Eastern Access (Newmarket Road) to Cambridge including siting of the Newmarket Road Park and Ride.


Number of meetings

We have held 9 full Parish Council meetings and discussed 183 agenda items.


8 Finance

Our financial statement is provided in an accompanying document. The charts below provide a brief visual summary, showing that 75% of our income is from the precept (£41,784.93). Expenditure is more widely spread including that required for the work of our Clerk and other administration, maintenance of our open spaces, providing grants to various village activities, and the cost of our Public Works loan for the rebuilding of the Memorial Hall.

Our income: operating income is £55,522.43
